Attachment A

The U.S. Department of Education (ED) has made available to all Title IV postsecondary schools approximately \$6.2 billion for students impacted by the Coronavirus pandemic. The CARES Act mandates, in part, that schools shall use no less than 50 percent of the funds to provide emergency financial aid grants to students for expenses related to the disruption of campus operations due to the coronavirus.

Athena Career Academy ("the school") is eligible to receive \$451,504, of which 50 percent or \$225,752 (student portion) is to be used exclusively for student emergency financial aid grants. ED has indicated that the school has significant discretion to develop its own system and process for determining how to allocate student emergency financial aid grants. The estimated total number of students eligible to participate in Title IV is currently 200.

To be eligible, the student must meet **ALL** of the following criteria:

- Be a current student (actively enrolled) since March 13, 2020
- The student has not since completed or withdrawn from their enrolled program
- The student is Title IV eligible

In addition, the student will be required to complete the attached brief student request form to determine eligibility by the close of business 07/02/2020. Once the form is completed and submitted back to me, it will be processed to determine eligibility. Once the form is processed, students will receive an email stating the determination of their request. If the student is determined eligible the amount issued to the student will be \$1,128.76
